Antitrust and Consumer Protection - Mr. Voorhees' antitrust practice encompasses counseling and litigation, with particular emphasis on pricing and distribution arrangements in the United States, and counseling trade associations on antitrust compliance matters. He is Vice Chair of the ABA Section of Antitrust Law, having previously served as International Officer, the Section's Delegate to the ABA House of Delegates, and Publications Officer. He also has served as one of the co-teachers of the firm's antitrust seminar at the University of Virginia School of Law since the early 1980s.

On consumer protection matters, Mr. Voorhees has represented clients in proceedings before the Federal Trade Commission on advertising and marketing matters and the Consumer Product Safety Commission on product safety matters. He has also represented clients in connection with consumer class action proceedings filed under state consumer protection and unfair business practices statutes.
