Data Privacy & Cybersecurity

In an era where digital technologies and data use are transforming every sector, our preeminent Data Privacy and Cybersecurity regulatory practice guides clients through the complex legal landscape shaping the digital economy.

We advise on a comprehensive suite of laws and regulations—from the GDPR, ePrivacy Directive, Digital Services Act, AI Act, Data Act, and Data Governance Act to the NIS2 Directive, Cyber Resilience Act, and DORA. Our expertise extends to consumer protection issues inherent in digital services, including pre-contractual transparency, product conformity with contracts and consumers' reasonable expectations, unfair commercial practices and terms, product liability, and close collaboration with product safety teams.

I attended the event and was quickly inspired by the panel of lawyers speaking about the firm's wide-ranging global work and its distinct collaborative culture. Although the focus at the time was on attracting candidates for the competition law team in Europe, an area outside my intended focus, the experience left a lasting impression on me of the firm's people and values.

A few months later, I learned that Covington was expanding its ESG, sustainability, and EU-focused regulatory practices, a focus that aligned perfectly with my career aspirations. I applied and was thrilled to be offered the position. In collaboration with the death penalty and fair trials charity Amicus ALJ, lawyers from across our EMEA and Asia offices assist those on death row in the US by reviewing records, creating case chronologies and preparing mitigation arguments.

Our Opportunities

We look for candidates with excellent academic qualifications, who are interested in working in an international setting. As an intern at Covington, you will have early responsibility and exposure to clients. Working within small teams and playing a significant role in complex substantive work, our interns work closely with senior lawyers and partners, and have a chance to make a real impact.

Programmes

Legal Internships

We offer six month legal internships across our five practice groups: EU Antitrust / Competition, Life Sciences, Data Protection, Public Policy and Environment, Social and Governance.

Over your six month internship, you will have the opportunity to gain hands-on experience working on cutting edge matters with international clients. You will receive training throughout your time with us and will be allocated an associate mentor who can help you navigate the firm from day one. Strong candidates can be considered for permanent associate positions upon completion of their legal internship.

Candidates should have obtained an LL.M and have excellent English language skills.

Application deadlines

Application will open from 4 September 2025. We recruit on a rolling basis for internships which run from April to September and October to March.

Summer Internships

We offer one month summer internship opportunities across our four practice groups from July to September.

Candidates join the firm for a one month internship, which is designed to allow you to gain hands-on experience and develop your skills. Candidates are integrated into their practice groups, benefiting from learning from experts in their specialist field within a supportive environment.

Applications for our summer internship opportunities will be reviewed on a rolling basis and will open from 4 September 2025.
